Notice to Licensee:

This report is required to be submitted on a monthly basis in accordance with Section 9(h) of the ABTC Rules and Regulations and § 20-10.1-140 (g) of the Northern Mariana Islands Administrative Code (NMIAC). The purpose of this report is to collect general information on the actual number of individual sales on a monthly basis from the above described items or products.

The ABTC division does not intend to collect information with respect to the actual inventory of alcohol and tobacco products currently at hand, nor the actual dollar amount of sales generated from the licensed retailer.

Failure to provide the above report on a monthly basis may result in an automatic suspension of license, which the suspension shall not exceed 48 hours from the date and time the license is suspended in accordance with Public Law 17-83, Section 3, §5598 as amended, and Section 11(b) of the ABTC Rules and Regulations, and § 20-1.10-150 (2) of the NMIAC. Subsequent or continuous failure to comply with this requirement may result in an automatic revocation of license upon the determination of the Director of ABTC and Secretary of Commerce in accordance with Public Law 17-83, Section 3, §5597(b) as amended, Public Law 19-30, and Section 11(a)(2), (b)(3) of the ABTC Rules and Regulations.
