This report includes a listing of admitted insurers and a summary of insurance business transacted in the CNMI from all admitted alien, foreign and domestic carriers during the 2015 calendar year.

During the reported year, the Office of the Insurance Commissioner licensed and regulated

- Two (2) alien carriers;
- Fifty-Two (52) foreign carriers;
- Seventeen (17) domestic carriers.

No new Certificate of Authority (COA) was issued for alien insurer.

Four (4) new COA was issued to an admitted foreign company:

Westport Insurance Company
Plateau Insurance Company
SilverScript Insurance Company
Central States Health & Life Co. of Omaha

No new Certificate of Authority (COA) was issued for a domestic insurer.

Direct premiums written for Property and Casualty experienced an 8.8% increase from \$24.70 million to \$26.87 million. Direct losses incurred increased by 176.4% from \$8.33 million in 2014 to \$23.03 million in 2015.

HIGHLIGHTS FOR 2015-16

###

The Office of the Insurance Commissioner (OIC) is a regulatory division directly under the authority of the Secretary of Commerce who serves as the Insurance Commissioner. Its mission is "Protecting CNMI consumers through regulation monitoring and education, while providing oversight of the insurance industry to best serve the public."

The division is tasked with the following but not limited to regulating the Commonwealth's insurance industry, recommended legislation, promulgation of rules and regulations and monitor financial condition of all admitted insurers.

The Introduction of Senate Bill 19-61 in September 2015

The legislation requires health insurance issuers to report to the Insurance Commissioner on the Medical Loss Ratio and medical claims to enable oversight over how health insurance companies spend premium dollars. Finally, the Legislation requires the CHCC, Insurance Commissioner, and Medicaid program to cooperate in the governance of the claims database in order to improve accountability for how health insurance premiums are spent. Upon passage, regulations will be promulgated for public comments prior to its adoption.

State Innovation Model Summit

On October 20th and 21st 2015, the OIC in collaboration with the CNMI Health Transformation Plan (CHTP) Team, participated at the State Innovation Model (SIM) Summit to provide a better understanding of the SIM initiative's potential impact and the critical task of the increasing health care coverage on Health systems of the CNMI.

NAIC Conferences, Meetings and Training Events

The Department of Commerce, as a member of the National Association of Insurance Commissioners and as State Base Regulators share similar goals which is "To assist state insurance regulators, individually and collectively, in serving the public interest and achieving the following fundamental insurance regulatory goals in a responsive, efficient and cost-effective manner."

It is essential for the continuance of regulatory training with the NAIC for the critical need of the CNMI in order to implement Regulatory Practices and Procedures, Authorization on Solvency and Financial Examinations, review and applicability of the emerging issues in the CNMI as a U.S. Territory, and for an accreditation review. These priorities will respond to the need for solvency review and financial examination of insurance carriers, promote transparency to consumers, and better services to both insurers and the public.
