In accordance with 4 CMC Division 7, §7112, I am pleased to present the 29th Annual Report of the Insurance Commissioner.

This report includes a listing of admitted insurers and a summary of insurance business transacted in the CNMI from all admitted alien, foreign and domestic carriers during the 2016 calendar year.

During the reported year, the Office of the Insurance Commissioner licensed and regulated

- Two (2) alien carriers;
- Fifty-Two (52) foreign carriers;
- Eleven (11) domestic carriers.

No new Certificate of Authority (COA) was issued for alien insurer.

One (1) new COA was issued to an admitted foreign company: Virginia Surety Company, Inc.

No new Certificate of Authority (COA) was issued for a domestic insurer.

Three (3) insurers were granted permission to withdraw their Certificate of Authority (COA) from doing the insurance market were:

Tacticor Insurance Company
OIC Marianas Insurance Corporation
Premier Insurance Company, Inc.

Direct premiums written for Property and Casualty experienced a 14.8% increase from \$26.8 million to \$30.8 million. Direct losses incurred decreased by 44.2% from \$23 million in 2015 to \$12.8 million in 2016.

### **HIGHLIGHTS OF 2016**

The Office of the Insurance Commissioner (OIC) continues to pursue its mission which is "Protecting CNMI consumers through regulation, monitoring and education, while providing oversight of the insurance industry to best serve the public." The Office of the Insurance Commissioner (OIC) is a regulatory division directly under the authority of the Secretary of Commerce who serves as the Insurance Commissioner.

The division continues to monitor the fiscal health or financial solvency of all admitted insurers and the compilation of various reports. As part of this review, insurers are required to file annually an audited financial statement and an annual statement.

It is crucial to ensure that regulations requiring fair, equitable and safe business practices are in place and are enforced for the betterment of the citizens of the Commonwealth.

In July of 2016, with the enactment of public law 19-56 which establishes the implementation of the Claims and Clinical Data Warehouse (CCDW), with the authority to coordinate health information exchange (HIE) and all-payer health insurance with local health care agencies. This enables studies of healthcare costs and value, healthcare disparities to improve accountability and how health insurance premiums are spent and to monitor the impacts of healthcare services. Module laws and regulations are under review for further implementation of these reportings which is in accordance with respect to Public law 18-34 namely, Premium Rate Review Process.

The division's ability to enforce rules and regulations despite the limited resources, the ability to forecast problems in advance, and the ability to solve problems in an expeditious manner is outstanding to the resources available to it through the NAIC which is critical to the CNMI.

Our success is measured upon the completion and implementation of short-term and long-term remedies to all issues concerning insurance which for the most part, exist and functions serving the perpetual needs of the general public and the insurance industry.
