NOTICE TO LICENSEE

This report is required to be submitted on a monthly basis in accordance with **Section 6 (§ 51922) of Public Law 24-02**. The purpose of this report is to collect accurate information on the number and types of betel nut products sold each month, including estimates of the average number of betel nuts per product type. This data will be used by the Department of Commerce, ABTC Division to assess compliance with the health warning labeling requirements, evaluate sales trends, and support nonprofit partners in enforcing the required health warning labels.

Failure to provide the above report on a monthly basis may result in suspension of license in accordance with 4 CMC § 51915(c) and § 51922(d). Suspension shall remain in effect until compliance is achieved. Subsequent or continuous failure to comply may result in the revocation of license upon determination of the Director of the Alcohol Beverage and Tobacco Control (ABTC) Division and the Secretary of Commerce, as authorized under Public Law 24-02.
